Agreement (Release, Waiver, Assumption of Risk, Indemnity)

1. **Release and Waiver.** In consideration for receiving permission for the Participant to participate in the Program, I hereby release, waive, discharge, and covenant not to sue Teens in Flight, its officers, servants, agents, and employees (collectively, "Releasees") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or relating to any loss, damage, or injury, including death, that may be sustained by the Participant, or to any property belonging to the Participant, whether caused by the negligence of the Releasees or otherwise, while participating in the Program; while in, on, or upon the premises where the Program is being conducted; while in transit to or from such premises; or in any place or places connected with the Program.
2. **Assumption of Risk.** I am fully aware of risks and hazards connected with flight and participating in the Program, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the Program. I hereby elect to voluntarily participate (or allow the Participant to voluntarily participate) in the Program, to enter upon the above-named premises, and to engage in activities knowing that conditions may be hazardous or may become hazardous or dangerous to the Participant and the Participant's property. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death, that may be sustained by the Participant, or any loss or damage to property owned by the Participant, as a result of being a participant in the Program, whether caused by the negligence of Releasees or otherwise.
3. **Indemnification and Hold Harmless.** I further agree to indemnify, defend, and save and hold harmless the Releasees, and each of them, from any loss, liability, damage, or costs they may incur due to the Participant's participation in the Program, whether caused by the negligence of any or all of the Releasees or otherwise.
4. **Binding Effect.** It is my express intent that this Agreement shall bind the members of my family and spouse, and my heirs, assigns, and personal representative, as a release, waiver, discharge, and covenant not to sue the above-named Releasees.

In signing this Release, I acknowledge and represent that:

- A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed.
- B. I grant full permission for Teens in Flight to take any and all pictures during training to be used at their discretion.
- C. No oral representation, statements, or inducements, apart from the foregoing written agreement, have been made.
- D. The Participant is at least thirteen (13) years of age and fully competent.
- E. I execute this Release for full, adequate, and complete consideration, fully intending to be bound by same.
